The team of coordinators will be collectively responsible for transitioning clients to the next level of care (if appropriate) by removing barriers, providing reminders, conducting outreach and developing and maintaining relationships with services and programs. These linkages will include but not be limited to treatment, family counseling, health care (including assistance and applying for PAC and Medicaid when applicable), employment, legal assistance, housing, child welfare, social services, transportation and peer-support providers.

The Care Coordinators will interface with clinical staff for review and verification of recommended services, identification of health care and recovery support needs, initiating referrals to the clinically recommended level of care and maintaining contact information. They can assist clients with scheduling appointments, arranging transportation and understanding any instructions they may receive. The Care Coordinators will work as part of the treatment team which establishes a Recovery Plan in coordination with patient and primary clinical counselors. The Care Coordinator will continue to provide these services post discharge for a period of 6 months.

Martha's Place is a state-certified recovery program for women in Baltimore seeking to overcome drug addiction and homelessness. Martha's Place offers both six-month transitional and long-term housing phases. The program serves women who are seeking recovery from substance abuse and have completed a 28-day detoxification treatment program, been referred by the drug-court system, or have attended 30 Narcotics Anonymous (NA) meetings in 30 consecutive days. Martha's Place does not offer its own detoxification program but can offer referrals as needed.

Martha's Place six-month transitional program combines residential housing with supportive services. Clients must receive individual and group counseling from Martha's Place certified clinical addictions counselor, daily attend NA & AA meetings, choose a sponsor and maintain contact, submit to regular and random drug testing, pay rent (\$10 nightly), participate in Money Management training and a 30-days blackout period.

Upon completion of the six-month transitional program, women are eligible for residency at Martha's Place long-term Single Room Occupancy (SRO) housing—a phase in which the residents apply the independent living skills learned during the six-month transitional program. The SRO program offers each client a personal room with shared kitchen, dining room, bathroom, and laundry areas.

To qualify for entry into the No Turning Back Program a potential resident must have at least (30) thirty days of clean time, he must pass an interview that involves all members of our program and staff and have an honest desire to change and rebuild his life. We believe that our time and space are valuable so if there is any question about your sincerity of changing your life, this may not be the program for you. There is a modified black-out period for all residents (Recovery House), which means that you would have to do ninety NA or AA meetings in ninety days, curfew at 8:30PM daily, chores to be completed weekly and sign in and out sheet used for ninety days. We have two group meetings per week and a house meeting on Saturdays. Our transitional program requires a minimum of six months clean time, thirty NA or AA meetings in thirty days and an interview process as stated above.

Once accepted into the program, our staff clinician will assist the resident in forming a treatment plan and discuss short and long-term goals. The clinician will follow up bi-weekly for a short period as he determines needed and then once a month.

Men who acquire jobs or are attending vocation training or attending school or college will be allowed to do those things as long as the staff agrees that other requirements are met. We believe that some activities enhance the growth process and that every individual is assessed according to his independent needs and desires.
