## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Office of the Governor – State Drug and Alcohol Abuse Council**

3 FOR the purpose of establishing the State Drug and Alcohol Abuse Council in the  
4 Office of the Governor; providing for the membership of the Council; requiring  
5 the Governor to designate the chair of the Council; providing for the terms of  
6 the members of the Council; authorizing members of the Council to receive a  
7 certain reimbursement; providing that a majority of the voting members of the  
8 Council is a quorum; authorizing the Council to adopt certain procedures and  
9 consult with State agencies; authorizing the chair to designate certain  
10 individuals to serve on a committee or task force of the Council; requiring the  
11 Council to meet at least four times a year; providing for the purposes and duties  
12 of the Council; requiring the ~~Office of the Governor to designate~~ Alcohol and  
13 Drug Abuse Administration to provide staff for the Council; specifying the terms  
14 of certain initial members of the Council; and generally relating to the State  
15 Drug and Alcohol Abuse Council.

20 **AND DRUG ABUSE PREVENTION, INTERVENTION, AND TREATMENT SERVICES IN**  
21 **THE STATE IN COORDINATION WITH STATE AND LOCAL CRIME PREVENTION**  
22 **AND HEALTH PROGRAMS;**

23                   **(2) PREPARE AND ANNUALLY UPDATE A 2-YEAR PLAN**  
24 **ESTABLISHING PRIORITIES AND STRATEGIES FOR THE ORGANIZATION,**  
25 **DELIVERY, AND FUNDING OF STATE DRUG AND ALCOHOL ABUSE PREVENTION,**

27 **IDENTIFIED NEEDS OF THE RESIDENTS OF THE STATE, INCLUDING THE**  
28 **GENERAL PUBLIC AND THE CRIMINAL JUSTICE POPULATION, AND THE**  
29 **STRATEGIES AND PRIORITIES IDENTIFIED IN LOCAL DRUG AND ALCOHOL ABUSE**  
30 **COUNCIL PLANS;**

1           (3) SUBMIT TO THE GOVERNOR AND, IN ACCORDANCE WITH  
2 § 2-1246 OF THE STATE GOVERNMENT ARTICLE, THE GENERAL ASSEMBLY, ON  
3 OR BEFORE AUGUST 1 OF EACH YEAR THE 2-YEAR PLAN AND ALL UPDATES AND  
4 INCLUDE RECOMMENDATIONS FOR THE COORDINATION AND COLLABORATION  
5 AMONG STATE AGENCIES IN THE FUNDING OF DRUG AND ALCOHOL ABUSE  
6 PREVENTION, INTERVENTION, AND TREATMENT SERVICES, PROMISING  
7 PRACTICES AND PROGRAMS, AND EMERGING NEEDS FOR STATE SUBSTANCE  
8 ABUSE PREVENTION, INTERVENTION, AND TREATMENT SERVICES;

9           (4) SUPPORT THE WORK OF THE LOCAL DRUG AND ALCOHOL  
10 ABUSE COUNCILS THROUGH FACILITATING COORDINATION AND  
11 COMMUNICATION AMONG THE COUNCILS, LOCAL STATE AGENCIES AND  
12 DEPARTMENTS, AND PUBLIC AND PRIVATE PROVIDERS AND PROVIDE  
13 TECHNICAL ASSISTANCE AS NEEDED;

14           (5) PREPARE ANNUAL SURVEYS OF ALL FEDERAL AND STATE  
15 RESOURCES USED TO FUND SUBSTANCE ABUSE PREVENTION, INTERVENTION,  
16 AND TREATMENT SERVICES AND REVIEW THE ALLOCATION OF THE FUNDS BY  
17 RELEVANT STATE AGENCIES FOR THE PURPOSE OF IDENTIFYING GAPS IN  
18 SERVICE DELIVERY, DUPLICATION OF SERVICES, AND OPPORTUNITIES FOR  
19 IMPROVED COORDINATION AND COLLABORATION TO ENSURE COST-EFFECTIVE  
20 AND QUALITY SERVICES AND CONSISTENCY WITH POLICY PRIORITIES  
21 ESTABLISHED IN THE STATE PLAN; AND

22           (6) FACILITATE IMPROVED LINKAGES OF THE COURT, CRIMINAL  
23 JUSTICE, AND CORRECTIONAL SYSTEMS WITH EXISTING DRUG AND ALCOHOL  
24 ABUSE SERVICES.

27 DRUG ABUSE ADMINISTRATION SHALL PROVIDE STAFF FOR THE COUNCIL.

28           SECTION 2. AND BE IT FURTHER ENACTED, That the terms of the  
29 appointed members of the State Drug and Alcohol Abuse Council established under  
30 Section 1 of this Act shall expire as follows:

31           (1) Five in 2013; and

32           (2) Five in 2014.

33           SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
34 October 1, 2010.
